POINT OF AIM

By Your VBA President

The January VBA meeting was a picture of cooperation and efficiency. With hourly reports on an approaching snowstorm, the business at hand was transacted with dispatch, and we were able to wrap it up by 1 p.m. Following is a partial summary of the meeting.

The Order of the Golden Feather honored Harry Benton, Princess Anne Bowmen, and Stewart Bradford, Prince Willaim Archers, by inducting them into the Order. Our congratulations to them.

The two proposed changes to the VBA Constitution were passed, making the office of the Corresponding Secretary an appointive position, rather than an elected one. To correct a note in the last "Flight," appointments will be approved by the full Executive Committee, and not by the President alone. Effective July 1, officers will serve two-year terms, instead of one-year terms, according to the other change.

Fred Crockett and Jim Overfelt presented samples of a most attractive membership recruiting poster, which was approved for VBA use. Copies of the poster are to be made up for distribution and use by the

Reporting on the agenda for the February National meeting, Bill Enders stated that all of the NFAA Sections have motions listed for approval of a Semi-Restricted Bowhunter Division. Therefore, he is sure that some form of the division will be approved at the meeting.

Doctor Dillow questioned the legality of scheduling Sectional Championships, as shown on your Tournament Schedules for Memorial Day weekend. It appears this is in opposition to the By-Laws. A motion on this point is to be voted on at the March VBA meeting.

As you will note elsewhere in this issue, a motion was made to change the By-Laws to increase the Corresponding Secretary's salary to two dollars per member per year. The present salary one dollar per member has lee in effect for many years, and it was felt that this is inadequate by today's economic standards. You should discuss this at your club, and have your Director prepare to vote your desires at the March VBA meeting.

Hunting Vice-President John Stockman reported that the Game Commission is to hold its regular meeting early, this year, in order to get the game laws out earlier. The meeting will be held February 25, at 9a.m., at the Game Commission offices in Richmond. John will represent VBA at the meeting, and you are welcome to attend if you wish.





NANCY LEE WESTERN LEAVING OFFICE

All too often it seems, when a person performs a service over a long period of time for us, we tend to overlook the need to plan for an eventual replacement. This applies in particular to Nancy Lee Western who, for eleven years, has performed the duties of VBA Corresponding Secretary with such efficiency, effectiveness and dedication that we have tended to feel she is indispensable. In spite of this, the time has now come when Nancy Lee finds it necessary that she step down from her position, and we are in urgent need for a replacement.

At the January VBA meeting, the Board of Directors changed the Constitution to provide that the Corresponding Secretary may be appointed by the Executive Committee, rather than having to go through the election process. In view of this, we are now appealing to the tire membership to assist in ating someone to fill this position. If you feel that you are qualified, please don't hesitate to apply. If not, look around you and consider whether one of your fellow members would fill the bill. The position of Corresponding Secretary is crucial to the operations of VBA. The success of VBA, and of archery and bowhunting in Virginia, depends to a considerable degree upon our filling this position with a qualified person.

New Corresponding Secretary Urgently Needed

What are the qualifications and duties of the job? Basically, typing and general clerical abilities are required. A room (or separate space) at least 8 by 10 feet in size will be needed to house the equipment provided for the office. Equipment includes a Scriptomatic Addressing Machine and a Mimeograph Machine. Transportation will be needed, to make bank deposits, transact postal business, attend VBA meetings, etc. Regarding the duties of the job, a partial listing follows:

Process applications for membership, 20-Pins, patches, and other awards and materials.

Provide reports to NFAA regarding membership, State affiliation, insurance and any other required matters.

Order and maintain adequate stocks of award pins, patches, etc.

Maintain record of each member's tournament scores, as submitted on club tournament reports.

Address "Flight" to members, separating by location, ZIP code and other requirements of Postal Service, and deliver to Post Office.

Purchase supplies and obtain needed equipment repairs, as required by the office.

Keep accurate record of all funds received and disbursed, and promptly deposit receipts in designated bank.

Prepare quarterly and annual reports of receipts, expenses and membership standing; submit reports at quarterly VBA meetings.

Prepare minutes of VBA quarterly meetings as submitted by Recording Secretary, and mail copies to officers, directors and clubs.

Attend quarterly meetings and participate with other officers in management of VBA affairs.

On the matter of compensation, VBA By-Laws currently provide that the Corresponding Secretary shall receive one dollar per member, per year (1037 members in 1976). A motion to be acted upon at the March meeting proposed that the pay be raised to two dollars per member. In addition, there is some reimbursement for travel, lodging and other expenses of the office. We readily admit that the salary may not be the main incentive for a person to accept this position. A love of archery, a desire to serve others and a considerable amount of dedication appear to have motivated our previous Corresponding Secretaries. Perhaps there are other considerations.

In seeking someone to fill this job, let's consider qualified men, as well as women. Ideally, a husband and wife team with a strong interest in archery would
